Family Service League's Staff Join in Physician's Offices *Integrated Care Means Improved Care*

The physician referred a 91 year old woman to see Diane because the woman seemed seriously depressed and had been losing weight. When Diane met with Mrs. Smith, she learned that the woman had been helping her son start a new business and had not paid her mortgage in 3 months. In an effort to save money, Mrs. Smith was taking her daily medication every three days and only eating the lunch provided by Meals on Wheels. Diane connected Mrs. Smith to an FSL Debt Counselor who found a tax break she was entitled to. Mrs. Smith is back on track, eating regularly, taking her medications daily and following a budget.

Integrated care breaks down the barriers between the provision of physical health and mental health. FSL has located behavioral health care in physician's practices in Suffolk County and primary health care is provided on site in the Diane Goldberg Behavioral Health Center in Bay Shore. Family Service League is at the forefront of integrating healthcare into our social work practice and has already established pilot programs for each of these models of care. Integrated care adds value through better quality, better outcomes and lower costs.

Adult Case Management Program Under Health Home Reconstruction

The Affordable Care Act is affecting many areas of health



care delivery across the country. Here at Family Service League, Adult Case Management services are transitioning to a “health home service delivery” model, which expands on the traditional medical home model to build linkages to other community

and social support, and to enhance care coordination with medical and behavioral health care, with the main focus on the needs of persons with multiple chronic diseases. The model is similar to our current case management model in that the core services are the same:

- Outreach and Engagement
- Comprehensive care management
- Care coordination and health promotion with client and all providers
- Comprehensive transitional care coordination from inpatient to community settings
- Referral and Linkage to community and social supports



Thanks to the Southdown PTA of Huntington and Splashes of Hope, the Manor Field Family Center has a beautiful new mural of Huntington Harbor at their after-school program. The children enjoyed a field trip to the locations portrayed in the mural – Coindre Hall and Gold Star Beach.

The health home model places great emphasis on a multi-disciplinary approach to care, where the focus is on medical/behavioral health care providers consulting and communicating with one another to develop a single comprehensive care plan.

The Butterfly Strokes Program at RECESS

Riverhead



Imagine the possibilities when a group of children ages 7-14, challenged with serious emotional disturbances and limited financial resources, were asked if they would like to take free swimming lessons! Sixteen children were thrilled to participate at Saf-T-Swim in Riverhead this summer.

These children were also participating in a unique program, the Butterfly Strokes Program, which uses swimming instruction “to keep children safe in and around water, to build self confidence and trust, to increase nutritional awareness and physical strength, and to heal from within.” The Marcie Mazzola Foundation partners with Saf-T-Swim to improve the lives of children who have suffered emotional, physical or sexual abuse. Family Service League is grateful to them for partnering with us to bring this wonderful experience to our RECESS program children.

In just six weeks, all 16 children made remarkable progress in their ability to swim, learning several strokes and how to dive safely. More importantly, they expressed their knowledge and appreciation of water safety that they lacked at the outset. The RECESS Supervisor Marlyn Garcia reports, “The children emerged with a new self-confidence that was noticeable. Some of them had to overcome visual perception challenges. Thanks to these lessons, they even learned to be instant problem solvers and decision makers.”

Journey House Travels from Hauppauge to Bay Shore

Journey House Personal Recovery Oriented Services (PROS) is an innovative recovery based mental health day program for individuals 18 years and older. The program offers a variety of evidence-based mental health services designed to empower participants and provide them with the information and education necessary to achieve their personal goals. The program in Hauppauge serves 65 individuals and an additional 50 students through our Flexible Employment Computer Training Program. Services include career exploration and job placement, disability education, clinical and psychiatric services, dual disorder and trauma counseling, and wellness self-management.



“2012 will be an exciting year for the program as Journey House relocates from our current Hauppauge site to our Bay Shore location,” reports Dave Sullivan, Program Director. “This expansion offers many opportunities for the individuals we serve. With a larger space and access to other programs/ services in the same building, it will allow us to

deliver the most comprehensive mental health programming to date. Eligible individuals from various Bay Shore programs can be referred to Journey House and our program’s consumers can access other programs - all under one roof.” The continuity of services is the future of mental health service delivery and FSL continues to embrace and expand on this approach. We look forward to this transition and offering the best services possible to the individuals we support.

The Huntington Interfaith Homeless Initiative (HIHI) is gearing up for our eighth season of ensuring all homeless men in Huntington are provided with a warm bed and hot meal during the winter months. The program was developed in 2004 in partnership with local houses of worship. Today, our strong partnership includes approximately



28 houses of worship and several businesses. Last season, our coverage began on December 1, 2011 and continued through March 31, 2012. Simply stated, we were able to provide 121 nights of shelter, hot meals, bag lunches, and breakfasts for men in need in the Huntington community. This year, the HIHI Program will begin on December 1, 2012 and end on March 31, 2013. The Center is a New York State licensed early childhood education and child care program. It was founded in 1981 and is based



on the Developmental Interactive Approach developed at the Bank Street College of Education. It’s goal is to create a school environment that is supportive of each individual child as they develop their full potential. We particularly seek to support the development of self-confidence, cooperation, self-esteem, and a love of learning.

Year-round full and half-day programs are available to meet the social, emotional and cognitive needs of children, ensuring them a developmentally appropriate educational experience. Along with our year-round program for young children, including operating the Mattituck-Cutchogue UFSD Universal Pre-K program, we offer two summer camp programs for children – one for children 18 months to 5 years of age and one for children 6 through 12 years of age.

Our year-round program serves children 18 months to 5 years of age. Our Universal Pre-K program serves only those who are 4 years of age and eligible for kindergarten in the Mattituck-Cutchogue School District the following September.

Foundations and Corporations make life better for FSL consumers

In November 2007, she accepted the position of P/T Quality Assurance Specialist for Family Service League's Adult Case Management Program. In 2009, she became the programs' Part-time Assistant Program Director. Ms. Powell has been an active member of the Suffolk County Multi Cultural Advisory Committee for 20 years, holding Chair and Co-chair positions. With her leadership, the MAC brought yearly trainings to Suffolk County that covered a broad array of issues in cultural disparities within our communities. In 2007, she was selected by Federation of Organizations for their "Woman of the Year" award, in honor of her advocacy work with the mentally ill. In July 2012, Ms. Powell was appointed by Commissioner Hogan to the New York State Office of Mental Health's Multi-Cultural Advisory Committee (MAC).
