



OFFICIAL RULES TO ENTRANTS FOR THE 95th ANNIVERSARY RAFFLE BENEFITING FAMILY SERVICE LEAGUE

All entrants of this cash raffle (“Raffle”) benefiting Family Service League (FSL) must be at least 18 years of age. FSL Board of Directors, Executive team, Development Staff and their immediate family may not participate. Extended family of those mentioned prior may participate.

By entering the Raffle, you agree that you have read, understood, and are bound by these Official Rules.

All Raffle entrants understand and agree that they are entering to win a \$9,500 cash prize and/or two \$500 dollar cash prizes. Each Raffle ticket represents one Raffle entry, and no more than 500 tickets will be sold for the Raffle. First two winners will be placed back in ticket pool for eligibility going forward. The winning entry shall be selected no later than 90 days after the raffle closing date. The Raffle prizes shall be as follows...

1 to 166 tickets sold 1st prize \$3,200 and two additional prizes of \$500.

166 to 333 tickets sold 1st prize \$6,400 and two additional prizes of \$500

333 to 500 tickets sold 1st prize \$9,500 and two additional prizes of \$500

Every entry has a 1/500 chance to win providing all tickets are sold.

You may enter the Raffle by purchasing a ticket(s). Raffle ticket purchases are not refundable for any reason. Each ticket purchased will then be mailed to the purchaser, and the ticket number will be recorded by FSL. Tickets may be purchased in one name only. FSL will hold the cash prize until valid winning entry(s) are selected.

All drawings that select raffle winner(s) will be conducted by FSL in a public forum. The raffle drawings will not occur later than end September 2021. FSL will attempt to notify the winner by all means provided and follow with written notification to the address of record. If FSL is unable to contact the winner, based on the information provided, within 10 business days of the drawing another winner will be selected.

The winner agrees to complete and return to FSL all documentation required before the winner may receive the cash Raffle prize. If the winner does not complete and return the required documentation to FSL within 7 business days, a new winner will be selected. The cash prize will be considered ordinary income for tax purposes and the winner may be required to pre-pay a portion of the tax liability prior to receiving the prize. Please consult with your tax advisor to determine what your personal tax liability would be should you win the Raffle. The winner agrees that all sales, use, and other taxes or fees are their own full and complete responsibility. Further, winner hereby agrees to indemnify and hold FSL harmless

from any and all liability related to the Raffle and/or the prize, and winner agrees not to hold FSL liable for any action derived from the use, transport, or enjoyment of the prize. It is the responsibility of the entrant to comply with any federal laws or regulations as well as any laws specific to the state or locality in which the entrant resides. In the event of a conflict between the Official Rules of this Raffle and New York State law, New York State law shall prevail. By entering the Raffle, you grant to FSL non-exclusive, worldwide, paid-up, royalty-free license to use your likeness and name to be used in perpetuity in any future collateral produced by FSL , which may or may not include appearing on/in FSL's website or publications. FSL reserves the right to refuse an entry and/or disqualify a winner, in its sole discretion, if it determines that any of these Official Rules are not met.
