OnTrackNY

Mental Health Empowerment for Teen and Young Adults

OnTrackNY is FSL's new mental health treatment program designed to empower young individuals (ages 16-30) in Suffolk County who are impacted by unexpected changes in their thinking and perceptions. This is a team-based, intensive, recovery-oriented program for those experiencing newly emergent non-affective psychotic disorders. These disruptions can include seeing, hearing, and believing things that are not real, or having strange persistent thoughts, behaviors, and emotions. The program helps the

participants pursue their goals in school, work, social relationships, avoid disability, and reduce hospitalization rates. FSL's team employs evidence-based practices to help people achieve their goals, prevent disability, and reduce hospitalization rates while offering flexible and accessible services including screening, psychiatric assessments, therapy, crisis intervention, case management, and peer support. FSL's Network of Shelters Offer Hope and Help

Two New Facilities Add Needed Housing for Suffolk's Most Vulnerable

The importance of safety and stability for children and adults living in staggering poverty and facing homelessness cannot be overstated. For children, there are often feelings of uncertainty that may undermine their confidence and self-worth, and have a negative impact on their social, physical, and educational growth. For adults and seniors, the trauma and stigma can be overwhelming.

We are pleased to announce that two additional shelters have been opened to help respond to the growing need for temporary, emergency housing on Long Island. FSL case manager and housing worker teams are committed to working with each family to ensure that they have access to services such as counseling, healthcare, education, and most critically, the availability of food. Additional assistance includes homework help, recreational opportunities, and developmentally appropriate programs for toddlers, children, teens, and

on-site adult education — all of which foster a caring, warm environment. Our model helps facilitate well-being and healing, while transitioning into affordable, permanent housing.

DASH: An Impactful 5-year Milestone

Five years ago, our vision for an innovative model of care was realized and we opened FSL's Diagnostic. Assessment, and Stabilization Hub (DASH) as a 24hour, 7 day a week, crisis care center. Today, it is an essential resource for those in crisis needing immediate assistance with issues such as suicidal thoughts, severe depression, anxiety, overwhelming stress, addiction, erratic behavior, and workplace or school trauma. Life's greatest challenges cannot be faced alone, and DASH provides immediate help.

We thank those who have supported our model of care including Suffolk County Legislators, Suffolk County Department of Health, NYS Office of Mental Health, NYS Office of Addiction and Support Services, Suffolk County Sheriff's Office, Suffolk County Police Department, and Stony Brook Health Services. In addition, we appreciate the many healthcare providers, law enforcement personnel, school districts, civic groups and donors, who have embraced DASH as a necessary resource for Suffolk residents. Working together has truly made a difference.

SeniorNet

We are all feeling the push to use new technology; be it a smartphone, tablet, laptop, desktop computer, or apps. Ombudsman

The Ombudsman program improves the quality of life for adult Suffolk County residents living in skilled nursing homes, assisted living, adult homes, and family type homes. FSL volunteer ombudsmen are certified by the NYS Long-Term Care Ombudsman Program. They visit residents to assist in resolving issues, assure rights are being protected, and that the services provided are helping to maintain patient's quality of life. Ombudsmen also serve as advocates fighting to reform policies and other issues impacting residents. Call 631-470-6753 for information about becoming a volunteer or accessing help for a loved one.

Caregivers Support & Education

We offer both group and individual counseling as well as educational resources for caregivers of loved ones over the age of 60. Weekly counseling sessions are available to help the caregiver handle their stress, better understand their role and options, and secure any assistance that may be available. Educational sessions are provided to community groups and businesses in a "lunch and learn" format, with topics such as dementia care, elder law, nutrition, and long-term care planning. Groups are specialized to meet the needs of adult children and partners of those with loved ones who have dementia and other chronic conditions. Caregiver services are free of charge. The program is funded by the Department of Health and Human Services through the NYS Office for the Aging and the Suffolk County Office for the Aging. LI Sound Senior Connections
